## **Background Information:**

- · Brunson Elementary is essential for downtown neighborhood students.
- Efforts to build a new school have been ongoing for over 20 years.
- The current school is in poor condition, located in a floodplain, and has been neglected in anticipation of the new building.
- The project faced delays and budget increases due to administrative decisions and post-Covid construction costs.
  - The school serves a less-advantaged population, including many unhoused students.
- The selected site for the new Brunson Elementary, formerly a Thomasville Furniture manufacturing plant, poses environmental challenges. Addressing potential brownfield issues is crucial to ensure the site is safe and conducive for a school, reflecting a commitment to environmental sustainability and the well-being of the school community.
